6) Canadian Hydroelectric for Massachusetts?

Deep beneath a granite mountain in the vast, snow-covered wilds north of the Saint Lawrence River, a frigid torrent surges through a massive, man-made tunnel, its white water propelling eight powerful turbines that generate electricity for hundreds of thousands of people. Within two years, a significant amount of that power, along with hydroelectricity from other plants in this Canadian province, could be exported to Massachusetts, providing the state with a long-awaited influx of renewable energy. 10) 2018 Massachusetts Recreational Trails Program Grant

February 1, 2018 deadline

Apply to receive funds for the construction or maintenance of trails and trail-related facilities, land acquisition or easements, trail assessments, and more! This year, DCR anticipates an increase in funding over past years. As such, eligible grant applications for up to \$100,000 in federal-share funding are now being accepted. 11) Scott's Miracle-Gro: GRO1000 Grassroots Grants February 19, 2018 deadline

Scotts Miracle-Gro's GRO1000 Grassroots Grants help foster the development of gardens and green spaces in the United States. Grants of up to \$1,500 are awarded to local communities throughout the country to help bring pollinator habitats, edible gardens, and public green spaces to more neighborhoods. The focus is on garden and green space beautification projects that incorporate the involvement and engagement of neighborhood residents and foster a sense of community spirit. The majority of grants are in the amount of \$500; a selection of the highest scoring applicants are awarded \$1,500. 12) USDA Agricultural Conservation Easement Program to Protect Wetlands March 2, 2018 deadline

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) has recently announced the availability of funding to help landowners protect and restore wetlands in Massachusetts. The funding is provided through the Agricultural Conservation Easement Program (ACEP), created by the 2014 Farm Bill to protect critical water resources and wildlife habitat, and encourage private owners to maintain land for farming and ranching. Through the voluntary sale of an easement, landowners limit future development to protect these key resources.For more information and to apply, click <u>here</u>.

13) Energy & Environmental Affairs FY 18 Conservation Assistance for Small Communities

March 30, 2018 deadline

The grant program provides funding to communities with a population of 6,000 people or fewer for the preparation of real property appraisals, Open Space & Recreation Plans (OSRPs), and other planning efforts. Funding is non-competitive; all eligible applicants will receive contracts on a rolling basis until all available funding is allocated. Funding is available on a first come, first-served basis. The program places special emphasis on helping traditionally underserved, low- and moderate-income communities build capacity for resiliency planning and investments in "greener" infrastructure. February 16, 2018 deadline

The National Trails Fund, sponsored by American Hiking Society (AHS), provides support to grassroots nonprofit organizations throughout the country working toward establishing, protecting, and maintaining foot trails in America. The Fund's grants, ranging from \$500 to \$3,000, help local groups build and protect America's public trails. Grants will be considered for the following: projects that have hikers as the primary constituency; projects that secure trail lands, including acquisition of trails and trail corridors and the costs associated with acquiring conservation easements; projects that will result in visual and substantial ease of access, improved hiker safety, or avoidance of environmental damage; and projects that promote constituency building surrounding specific trail projects, including volunteer recruitment and support.
