4) **Environmental Protection Agency Announces Improvements to Keep Massachusetts Waters Clean**

Excerpts from Environmental Protection Agency, May 10, 2018 by David Deegan

On May 10, 2018, the U.S. Environmental Protection Agency (EPA) announced a major

step forward for Massachusetts' water quality with improved stormwater management requirements as well as an array of training and implementation tools to assist municipalities with implementation. The new permit (which EPA issued in 2016 but has not yet taken effect) will update stormwater management efforts across the state's urbanized areas that will better protect rivers, streams, ponds, lakes, and wetlands from harmful pollutants in many communities. While updating ecological protection, the permit also maximizes flexibility for individual municipalities to tailor their efforts to individual needs and local conditions. 5) Community Preservation Act Trust Fund Increase is Adopted by Senate

Excerpts from The Community Preservation Coalition, May 22, 2018

During the Senate budget debate on May 22, Senator Cynthia Stone Creem's budget amendment to increase the CPA Trust Fund was adopted. [Senate Budget Amendment #3 \(Community Preservation Act\)](#) was the very first amendment that was adopted during the Senate Budget debate on May 22 after a roll call vote. Each Senator went on record to individually vote in favor of adopting the amendment. The amendment calls for a \$30 increase to the recording fees at the State's Registries of Deeds. Preliminary estimates indicate that the increase would restore the first round distribution to a level near 30%.

Next, a six-member conference committee will reconcile the differences between the House and Senate versions of the FY19 state budget. CPA revenue was included in the Senate version of the document, but not the House, so the Conference Committee will have to agree to include it in the final version of the budget. The Committee usually issues its report by the end of June, after which it will head to the desk of Governor Baker.

The Executive Office of Energy & Environmental Affairs' Division of Conservation Services (DCS) is seeking applications for the FY 2019 [Parkland Acquisitions and Renovations for Communities](#) (PARC), [Local Acquisitions for Natural Diversity](#) (LAND), and [Conservation Partnership](#) grants. The Open Space Institute (OSI) protects scenic, natural, and historic landscapes to provide public enjoyment, conserve habitat and working lands, and sustain communities. OSI's Community Forest Fund awards grants in the northern New England states of Maine, New Hampshire, and Vermont. The focus is on projects that integrate community, economic, and conservation goals, such as efforts that create and retain jobs, promote sustainable forestry, conserve land, and increase and deepen community involvement in land stewardship. The Fund awards matching capital grants to support the purchase of conservation easements and fee interest in land.
