## **5) Land and Water Conservation Fund Reauthorized**

Paraphrased from Land and Water Fund Coalition, March 12, 2019

The President has signed a bill permanently reauthorizing the Land and Water

Conservation Fund (LWCF), among many other environmental protection and land use measures including designating 1.3 million acres of land as wilderness and classifies 255 miles of river in Massachusetts and Connecticut as wild, scenic, or recreational. The bill had enormous bipartisan support, passing in the Senate by 98-2 and by 363-62 in the House. To learn more, visit [here](#).

## **6) New Budget would Aid Environmental Agencies**

Governor Baker's proposed 2020 fiscal year budget would increase environmental spending, helping state environmental agencies to increase staff. The budget would increase environmental spending by 6 percent over the previous year, and would include \$97.1 million for the Department of Conservation and Recreation, \$60.8 million for the Department of Environmental Protection, and \$31.1 for the Department of Fish and Game. ## **8) \$1 Billion Environmental Grant Program Proposed**

A \$1 billion grant program has been proposed that would fund municipal investments in climate resilience programs. The program, proposed by House Speaker Robert DeLeo, would allocate \$100 million each year over the next 10 years through the Executive Office of Energy and Environmental Affairs. ## **9) DOR Issues Estimate for Fall 2019 CPA Fund Distribution**

Paraphrased from MA Department of Revenue news release

The Department of Revenue (DOR) has released a budget memo to municipalities summarizing its estimated Community Preservation Act (CPA) Trust Fund distributions. To account for the decreasing CPA Trust Fund distributions, the Community Preservation Coalition and other entities advocate for a bill that would restore state and local partnership for CPA. The introduced legislation, "An Act to

### **10) MA Rivers Designated Wild and Scenic**

Sections of the Nashua, Squannacook, and Nissitissit rivers in Massachusetts and New Hampshire have been designated as part of the National Wild and Scenic Rivers System. This designation follows the effort of the Nashua River Watershed Association, Nashua River Wild and Scenic River Study Committee, eleven communities, and politicians from both states. With 52.8 miles of river protected, these three rivers join the 0.25% of rivers in the nation that are protected under the National Wild and Scenic River Act. For more information, read [here](#).

### **11) Proposed Boston Wetlands Protection Act Gains Support**

A proposed city ordinance to protect the wetlands around Boston has garnered support from the majority of City Council members. Under this act, wetlands around the city would have greater protection from proposed development and could be designated as Areas of Critical Environmental Concern by the Boston Conservation Commission. ### **12) \$3.7 million in Conservation Grants awarded across State**

\$3.7 million in conservation grants have been awarded to non-profits across Massachusetts, including eight land trusts and 11 communities. Awarded projects include \$400,000 for the purchase of Long Pond Woodlands in Brewster, \$400,000 for the Beech Trees Dunes Project to improve forest habitat in Provincetown, and \$85,000 to protect beachfront habitat on Cape Cod Bay in the Great Hollow Beach Land Acquisition. ### **27) Stewardship Assistance and Restoration on APRs-- MA Department of Agricultural Resources**

April 17, 2019 Deadline

The MA Department of Agricultural Resource is seeking applications for stewardship and restoration projects on properties covered by Agricultural Preservation Restrictions. Funds may be used for materials and contracted labor or equipment rental costs to clear or reclaim inactive fields that are out of production at no fault of the current owner. Examples of eligible projects include clearing vegetation, pulling rocks or stumps, cutting back grown in field edges, or reseeding or applying soil or crop amendments to inactive cropland or pastureland in order to bring it back into production. Funding may be also be used to restore farm resources that have been negatively impacted by flooding, erosion, storms, tornadoes and other natural disasters. Grant funds of up to \$25,000 are available on a cost reimbursement basis with a 15% match of total project costs required by the farm participant.
