## **2) Lentowski Reflects on 47 Years Leading Conservation Foundation - With Correct Link**

Jim Lentowski, a long-time hero of conservation on Nantucket, is officially retired, after 47 years leading the organization that today protects more than 9,000 acres of open space across the island, including Sanford Farm, Tupancy Links, Squam Farm and Swamp, the Milestone and Windswept cranberry bogs, Norwood Farm and the University of Massachusetts-Boston's Nantucket Field Station in Quaise.

"What's next? After 47 years of working to create, from the bottom up, a one-of-a-kind program that reflects the founders' goal to preserve Nantucket's unique natural character, it's time to stop, wind down and consider how best I can use my experience, contacts and interests in the years ahead," Lentowski, 71, said. ### **3) The New Development That Promises to Transform Boston's Waterfront**

Countless cities across America have sprawling, empty waterfront sites that once hummed with factories, trucks, and trains. For Boston, it was its Seaport District—a swathe of land approximately a mile deep and long, located east of the city's downtown. And while the Seaport District still features its fair share of industrial buildings and surface parking, a 23-acre development situated right next to downtown Boston is sprouting new towers: around eight blocks have complete buildings, with one block under construction and nine blocks awaiting development. ## **LEGAL/LEGISLATIVE NEWS**

### **4) Conservation Land Tax Credit Update**

The proposed changes to the Conservation Land Tax Credit (CLTC) program were not included in the state's House-Senate Conference Committee's budget during this legislative session. The proposed changes would have raised the annual credit cap from \$2 million to \$5 million per year by gradually increasing the cap over the next three years. Currently, new landowners wishing to apply for the tax credit will not be eligible for funding until 2020 or later, as the cap has already been reached for the next two years. This has delayed the conservation of important natural resources and complicated projects that are funded by grants with specific time constraints. MassLand and our partners will be meeting this fall to discuss plans for the next legislative session. Thanks to all of our members who contacted their legislators in

support of the CLTC program, and to those legislators who advocated strongly for the proposed changes.

## 5) *Endangered Species Act at Risk*

Excerpts from Mass Audubon, July 23, 2018 by Christina Wiseman

Over the past few weeks, the federal Endangered Species Act (ESA) has come under unprecedented threat. For 45 years the law has successfully protected wildlife, including species like the Bald Eagle, which the ESA helped bring back from the brink of disappearing in the US. In fact, thanks to the ESA, more than 99 percent of the nearly 1,800 animals and plants protected by it have been saved from extinction.

Now, the ESA is under attack. In the past two weeks, more than two dozen pieces of legislation, policy initiatives, and amendments designed to weaken the law have surfaced. Many of these proposed changes have been under the guise of "updating" or "reforming" the Act, but in reality would undermine its core principles and gut its scientific basis for protecting wildlife.

Earlier this month, Mass Audubon and 420 other national, state, and local conservation groups sent a letter to US Senate and House leadership voicing our overwhelming support for the ESA. The Massachusetts environmental community will be continuing to follow this issue closely, and will keep you updated with actions you can take to keep the ESA firmly in place.

The Massachusetts Forest Legacy Program is now accepting project proposals for consideration in the Federal Fiscal Year 2020 application process. The Forest Legacy Program is a partnership between the Massachusetts Department of Conservation and Recreation and the USDA Forest Service to protect environmentally important forests from conversion to non-forest uses. The Federal government may fund up to 75% of project costs, with at least 25% coming from private, state or local sources. The National Fish and Wildlife Foundation (NFWF) is pleased to announce the National Coastal Resilience Fund. Projects funded under this national program will provide benefits to communities, as well as for fish and wildlife. In partnership with NOAA, NFWF will make investments to advance identified priorities for restoring and strengthening natural systems so they can protect coastal communities from the impacts of storms and floods and enable them to recover more quickly, while also enhancing habitats for important fish and wildlife populations.

NFWF will award up to \$30 million in grants to create, expand and restore natural systems in areas that will both increase protection for communities from coastal storms, sea and lake level changes, flooding, and coastal erosion and improve valuable habitats for fish and wildlife species. NFWF will invest in projects in two focus areas:

- Project Planning and Design
- Project Implementation
