1) Sign On By Friday: Oppose the Clean Water Rule Repeal!

Please consider adding your organization to this sign-on letter opposing the Trump Administration's proposed repeal of the 2015 Clean Water Rule (aka Waters of the US or WOTUS). **The public comment period closes Monday 8/13. Please sign on by Friday 8/10.**

This rulemaking is the administration's second attempt at repealing the Rule, adding supplemental justification to the 2017 proposal that was never finalized. It will be followed later this summer or fall with a replacement "Dirty Water Rule" that will seek to narrowly define Waters of the US and limit the scope of the Clean Water Act. Act now!

The latest open space proposal comes from the Trustees of Reservations, which is bidding to rehab a dilapidated pier owned by the Massachusetts Port Authority. 9) Free Aquatic Plant Identification Workshop

Wednesday, August 15, 2018, 6:00pm

Bill Ashe Visitor Center, Oxbow National Wildlife Refuge, 80 Hospital Road, Devens, MA

Do you have a favorite paddling or swimming spot where you've found an aquatic plant and wondered if it's native or invasive? Are you part of a pond committee or river group looking to protect the health of your waterway from invasive plant species? The Nashua River Watershed Association invites you to join them for this workshop. This one and a half hour class will be led by Tom Flannery, Aquatic Ecologist with the Massachusetts Department of Conservation and Recreation's Lakes and Ponds Program.

The workshop begins with an introduction to the invasive non-native species issue, how exotic species are introduced into our waterways, methods of dispersal, basic terminology, and guidance on performing bi-weekly monitoring and completing plant surveys. The remaining 3/4 of the class will engage participants in hands-on identification. A variety of non-native and native plant species are provided, and people are encouraged to bring in their own samples of aquatic plants.

September 10, 2018 deadline

The Massachusetts Forest Legacy Program is now accepting project proposals for consideration in the Federal Fiscal Year 2020 application process. The Forest Legacy Program is a partnership between the Massachusetts Department of Conservation and Recreation and the USDA Forest Service to protect environmentally important forests from conversion to non-forest uses. The Federal government may fund up to 75% of project costs, with at least 25% coming from private, state or local sources.
