7) Baker open to fee hike to boost state CPA match

8) 2018 Statewide Trust Fund Distribution Announced

Excerpts from the Community Preservation Coalition, November 15, 2018

\$10 million from the state budget surplus has been secured to use as state match for Community Preservation Act communities. This will allow a 2018 match of 19%, rather than 13.8% match secured from fees at the Registries of Deeds alone. When the two sources of funding are combined, it brings the round one match up to 19% for all CPA communities. Cities and towns that adopted CPA with a full 3% local property tax surcharge will receive a higher percentage. In total, more than \$33 million will be paid to the 172 communities eligible for a distribution. Click <u>here</u> for the full story.

9) Land Trust Alliance presents the case for land trusts to the IRS

Excerpts from the Conservation Defense Network E-newsletter, November 15, 2018

Land Trust Alliance president Andrew Bowman testified on a conservation issue of national consequence during a public hearing earlier this month at IRS headquarters. In remarks he delivered to IRS and U.S. Treasury Department officials, the Alliance president said a proposed State and Local Tax (SALT) deduction rule change is "too sweeping" and "quite contrary to the intent of Congress."

The IRS and U.S. Treasury Department are considering significantly reducing deductions available to people who donate to charitable organizations and then receive state or local tax credits. This includes the donation of conservation easements and even land. These reductions would eliminate - or substantially shrink - an important incentive for donors and would slow the rate of land conservation. For Bowman's full testimony, click <u>here</u>.

11) Baker-Polito Administration Announces Support for River Restoration and Climate Adaptation Projects

The Baker-Polito Administration has announced \$188,600 in state grant funds for river and wetland restoration projects in Falmouth, Northampton/Easthampton, North Adams, and Plymouth through the Department of Fish and Game's Division of Ecological Restoration's Priority Projects Program. The program provides projects with grant funding, project management, and contracted technical services for wetland and river restoration, urban river revitalization, and streamflow restoration projects that present the greatest benefit to the Commonwealth, ecologically, socially, and economically. 12) Massachusetts Integrated State Hazard Mitigation and Climate Adaptation Plan Now Available

This plan, the first of its kind to comprehensively integrate climate change impacts and adaptation strategies with hazard mitigation planning, also complies with current federal requirements for state hazard mitigation plans and maintains the Commonwealth's eligibility for federal disaster recovery and hazard mitigation funding under the Stafford Act. TerraCorps is a national service program helping communities conserve and secure land for the health and well-being of people and nature. It supports 36 AmeriCorps service members who serve with nonprofit organizations across the state to tackle issues around land access, conservation, and revitalization. This year it has six 1,200 hour service member positions that will run from December 3rd, 2018-July 26th, 2019. 16) Baker-Polito Administration Announces Over \$1 Million in Land Use Planning Assistance Grants

The Baker-Polito Administration has announced \$1,030,659 in grants for 31 projects to improve municipal land use planning and development through the second round of grants from the Planning Assistance Grant Program. Through this program, the Energy and Environmental Affairs provides municipalities funding to undertake public processes and hire technical expertise to improve their land use practices, diversify housing choices, mitigate and prepare for climate change impacts, and conserve and develop land consistent with the Massachusetts Sustainable Development Principles. 17) Federal Court Supports New England Marine Monument

A federal court has supported the Northeast Canyons and Seamounts National Monument (NCSNM) by dismissing a challenge to the monument from an industrial fishing group. The first marine monument in the Atlantic Ocean, NCSNM is located off the coast of New England and covers 4,913 square miles. The national monument protects a biodiversity hotspot that includes undersea canyons, extinct undersea volcanoes, deep-sea corals, and numerous whale, seabird, and fish species. Support for the national monument in the year-long public engagement process before its designation included 300,000 citizens, 145 scientists, 100 businesses, ten aquariums, and dozens of fishing and conservation organizations. 19) Solar Massachusetts Renewable Target Program: Massachusetts' new solar initiative begins accepting applications 11/26

The Solar Massachusetts Renewable Target (SMART) Program is the newest program established to support the development of solar in Massachusetts. The tariff based incentive is paid directly by the utility company to the system owner, following the approval of the application by the Solar Program Administrator. The SMART Program is a 1600MW declining block incentive program. Eligible projects must be interconnected by one of three investor owned utility companies in Massachusetts: Eversource, National Grid, and Unitil. Each utility has established blocks that decline in incentive rates between each block. For more information, click <u>here</u>.

28) Stewardship Assistance and Restoration on APRs

December 7, 2018 Deadline

The Department of Agricultural Resources invites responses from farmers who own or operate farm land under the Agricultural Preservation Restriction ("APR") Program who wish to participate in the Stewardship Assistance and Restoration on APRs Program. The purpose of the program is to address stewardship or restoration issues on farmland resources in order to maximize productive agricultural use of the protected resource. Funding of up to \$25,000, with a 15% match, may be available for identified improvements that will help restore or enhance the protected land resources on an APR farm property. 29) Watershed Monitoring Grant

The Baker-Polito Administration is pleased to offer a new Watershed Group Monitoring Grant program to eligible volunteer groups across the state. It is a 5 year program to assist cities and towns to replace or preserve bridges with spans between 10' and 20'. Each municipality may qualify for up to \$500,000 per year. The DWSP grant program provides financial assistance to public water systems and municipal water departments for the purchase of land or interests in land for the following purposes: 1) protection of existing Department of Environmental Protectionapproved public drinking water supplies; 2) protection of planned future public drinking water supplies; or 3) groundwater recharge.
