- Hosted the 18th Annual Land Trust/State Agency Retreat

- Produced three multi-session learning collaboratives and several Stronger Together topical networking sessions for land trust leaders
- Created a new toolkit to help conservation advocates communicate the economic value of land conservation to municipal decision-makers
- Deepened our engagement in policy advocacy, helping to advance the Public Lands Protection Act




