# 2020 Massachusetts Land Conservation Conference

- Unfortunate but necessary cancellation very late in the game

- Learned a lot and got both positive and constructive feedback



## **2021 Conference**

- Planning Committee met June 11 and meets again mid-July
- Given unknowns and planning timeline, opted for an online event



## Program Priorities for Coming Year




#### Challenges organizations are facing (excluding funding)

## **Proposed Response:** *"Land Trust Capacity-Building Initiative"*

- Training Series on best practices: With skilled faculty, more in-depth and interactive than conference workshops. Possible topics: CR Enforcement; Insurance & Liability; Models for Land Trust Collaboration; Board Recruitment and Succession Planning; Landowner and Community Outreach
- Networking by Region or Theme: Focused on strengthening relationships and peer learning; held remotely until we can gather live
