### Native Land Conservancy Receives 10+ Acres from Generous Donor

In November 2020, Jacqueline Rivero deeded 10+ acres comprising Simpkins Bog to the Native Lands Conservancy. The Yarmouth Conservation Trust holds the conservation restriction. Jacki inherited Simpkins Bog from her uncle Emmanuel DiTiberio (1921-1995), and wanted to ensure that the land was given back to its original inhabitants and not developed. The property comprises most of the headwaters of Whites Brook, the major freshwater tributary to Chase Garden Creek in Yarmouth and Dennis. The bog is believed to have been in cranberry production from the 1870s until the 1960's. Nowadays, it is a quiet, contemplative place, with a brook, much moss, and paths that push into the woods.

## Policy

### **Act Today! Urge Governor Baker to Sign the Climate Bill**

On January 4th, the Massachusetts Legislature passed An Act Creating a Next-Generation Roadmap for Massachusetts Climate Policy with overwhelming bipartisan support. The Governor has until midnight on Thursday, January 14th to sign the bill into law, or the legislature will have to start from scratch in the new session. **Please urge the Governor to sign this bold legislation!** Click [here](#) for contact information and sample scripts, courtesy of MCAN. The result of months of negotiations between the House and Senate, this bill sets the Massachusetts' 2050 emissions limit to the new global standard – net zero – and defines a transparent process for achieving them. It also codifies critical environmental justice language and makes natural and working lands part of our climate strategy. Read a full summary of the bill [here](#).

### **Great News on State Budget**

Thanks to advocates' outreach to the legislature, the House and Senate overrode the Governor's vetoes and restored the Conference Committee recommendations for the Department of Conservation and Recreation (DCR), Department of Environmental Protection (DEP), and the Division of Ecological Restoration (DER). These line items, in addition to the Natural Heritage and Endangered Species Program, will receive increases in the FY21 operating budget.

### **MA, CT, RI, DC First to Launch Groundbreaking Program to Cut Transportation Pollution, Invest in Communities**

The bipartisan [Transportation and Climate Initiative Program](#) (TCI-P) will put a brake on pollution while investing \$300 million per year in cleaner transportation and healthier communities. The TCI-P will require large gasoline and diesel fuel suppliers to purchase allowances for the pollution caused by fuels they sell in participating jurisdictions, with each jurisdiction determining how to best invest program proceeds. Massachusetts Governor Charlie Baker commented, "By partnering with our neighbor states with which we share tightly connected economies and transportation systems, we can make a more significant impact on climate change while creating jobs and growing the economy as a result." ### **Opportunity: POCIE (Professionals of Color in the Environment)**

POCIE is a new, regional professional networking community for BIPOC environmentalists from all sectors in Massachusetts with the goal of gathering, mentoring, networking, and collaborating. ### **Paycheck Protection Program (PPP) Opening Again**

The COVID Relief bill enacted in late December authorized \$285 billion in new PPP funding for hard-hit small businesses and nonprofits. Existing PPP borrowers may be eligible to apply for additional funds if they experienced at least a 25% decrease in gross receipts in a given quarter from 2019 to 2020. **Those that did not receive PPP loans in prior rounds are eligible to apply, even if they did not experienced a 25% drop in gross receipts.** Borrowers will also benefit from an expansion of eligible costs and a simplified forgiveness process. But this article in the *Globe* is the best collection of data on the subject". Some highlights include: A Harris poll in the midst of the pandemic found that 69 percent had a renewed appreciation for the outdoors, and quotes like this: "People are realizing, gee, that 30-minute outdoor hike or walk in a park feels good and I want to keep doing it," said Lise Aangeenbrug, Executive Director of the Outdoor Industry Association. ### **2021 Covid Relief Bill Includes Tax Breaks for Charitable Giving**

The 2021 Covid relief bill signed into law in late December extends the universal charitable deduction through 2021. Notably, married couples who don't itemize may deduct up to \$600 above the standard deduction for their 2021 donations. In 2020, couples were allowed \$300 above the line, the same as individuals. Individuals may continue to deduct \$300 above the standard deduction for 2021.

### **USDA-NRCS Agricultural Conservation Easement Program (ACEP)**

*Deadline: Monday, March 1*

The Agricultural Conservation Easement Program (ACEP) provides financial and technical assistance to help conserve agricultural lands and wetlands and their related benefits. Under the Agricultural Land Easements component, NRCS helps Indian tribes, state and local governments and non-governmental organizations protect working agricultural lands and limit non-agricultural uses of the land. Under the Wetlands Reserve Easements component, NRCS helps to restore, protect and enhance enrolled wetlands. To enroll land through agricultural land easements, eligible partners may submit proposals to NRCS to acquire conservation easements on eligible land. To enroll land through wetland reserve easements, landowners may apply at any time at the local USDA Service Center.
