#### Night Pasture Protected in Hardwick

Night Pasture is a 33 acre parcel of a 200+ acre farm in Hardwick, originally purchased by the Robinson family in 1892. Ray and Pam Robinson, the last of four generations of Robinsons to own the property, recently retired and had to sell the farm, but donated Night Pasture to the East Quabbin Land Trust (EQLT). That donation will ensure farming can continue on at least a portion of the original farm, which transitioned from conventional milk production to an organic raw milk and award-winning cheese operation in 2006. Says Ray, "It feels good to see it preserved, and we hope the gift of the Night Pasture is the start of a larger block of conserved land in the future". Conservation values of the property include historic farmland, scenic landscape, wildlife habitat in

the hedgerows and fields, and protecting the water quality of nearby Danforth Brook. Importantly,

Night Pasture is adjacent to another piece of land that is likely to be donated to EQLT through the CLTC program in a few years. EQLT looks forward to continuing the Robinson's tradition of allowing the land to grow good food, and has started discussions with local farmers about grazing and haying in the next growing season. Future plans for the land may include a walking trail, grazing animals, and wildlife monitoring. <u>Read more</u>.

# Policy

#### A 30x30 Update

The Interior Department, in coordination with the Agriculture Department, Commerce Department, and the Council on Environmental Quality, announced a <u>public comment period</u> on the development of the American Conservation and Stewardship Atlas. According to the Interior Department, the atlas will be used to reflect baseline information on the lands and waters that are conserved or restored as part of the America the Beautiful initiative. Deadline for comments is March 7. The Land Trust Alliance, on behalf of its members, will submit written comments ahead of the deadline. **If your land trust plans to submit comments**, please email Chelsea Welch, the Alliance's energy and

Information garnered here will inform the 2022 Massachusetts Climate Change Assessment, which the Executive Office of Energy and Environmental Affairs is undertaking to identify the most pressing current and future climate challenges and impacts. Ultimately, the conversations will inform how the study will assess statewide climate impacts, and how the State prioritizes actions to address these challenges as part of the upcoming <u>State Hazard Mitigation and Climate Adaptation</u> <u>Plan</u> 2023 update.

#### In Memorium

With heavy heart we note the passing of Brian Rehrig, an inaugural member of MLTC's Conservation Advisory Council. Brian was the long-time face of the Fields Pond Foundation, as well as a founder of the allvolunteer Arlington Land Trust. As Bob Wilber, Director of Land Conservation at Mass Audubon, notes: "Many marveled at how Brian was so well connected, so well respected, and so politically adept – pulling on multiple levers simultaneously to make [projects] happen". Brian was a great conservationist and

#### Wildlands Trust Surpasses 50 Communities Served in Southeastern Massachusetts

<u>Wildlands Trust</u>, a regional land trust in southeastern Massachusetts founded in 1973, marked the end of 2021 with the donation of 65 acres of land in Foxborough, which expanded its service area to 51 communities. The organization celebrated several other year-end acquisitions including the 16acre Hart conservation restriction, which adds to an existing assemblage of protected land along Eagles Nest Creek in Duxbury; and a 17-acre property within the headwaters of Leonard Washburn Brook in Lakeville. The self-described "small organization with a big reach" has protected nearly 13,000 acres of open space since its founding.

#### Five MLTC Members Awarded New MassWildlife Grants

Five MLTC members were funded in the inaugural year of MassWildlife's Climate Change Resilience Grant Opportunity program, which provides financial assistance to private and municipal landowners of conserved land to improve resiliency in ecological communities susceptible to climate change. Berkshire Natural Resources Council, Norcross Wildlife Foundation, Sudbury Valley Trustees, and The Trustees will use funds for a range of habitat management projects across the state. #### **Burial Alternatives Draw Attention**

A January 25th <u>Boston Globe article</u> shares how Better Place Forests, a for-profit company based in California, purchased 200 acres of <u>mostly wooded land in the town of Florida</u> and now offers the opportunity to scatter one's cremated remains there at a cost of nearly \$6000 and up. The company tells MLTC that it is in the process of granting a Conservation Restriction on the property to an accredited land trust. Though some question claims that cremated remains provide any substantial nutrient value to trees, this Berkshires project joins the company's existing forest in Connecticut's Litchfield Hills as their second entry of this business model in the Northeast. Another company, <u>Eternal Roots</u>, states on its website that it will open a similar memorial forest "in the eastern foothills of the Berkshires" later this year; no details are provided on whether that property will be protected by a Conservation Restriction.

Meanwhile, the non-profit <u>Green Burial Massachusetts</u> has been working for years to promote environmentally friendly alternatives to traditional burial and cremation, highlighting the fact that both have significant environmental impacts. The organization's website features <u>a searchable</u> <u>list</u> of the growing number of Massachusetts communities that allow natural burial, defined here as burial without any embalming, metal casket, liner or vault, with only minimal grave markers. The organization is currently partnering with <u>Kestrel Land Trust on a search for property</u> to create the state's first cemetery dedicated exclusively to natural burial. ### Grants

#### **U.S. Standard NAWCA Grants**

#### Application deadline: Friday, February 25

This matching grants program supports public-private partnerships carrying out projects that involve long-term protection, restoration, and/or enhancement of wetlands and associated uplands habitats for the benefit of all wetlands-associated migratory birds. Learn more and apply.

#### **Cornell Land Trust Bird Conservation Initiative Grant Program**

#### Application deadline: Tuesday, March 1

These grants provide between \$5,000-\$25,000 for projects that contribute to bird conservation on private lands through activities such as (but not limited to) strategic planning, outreach, habitat management, stewardship, bird monitoring, eBird use, capacity building, and land or easement acquisition. Funds will be dispersed at the end of May/June in the following categories: Capacity and Partnership Projects – up to 6 grants of \$5,000 each; Management and Restoration Projects – 8 grants of \$25,000 each. #### Northeast Bird Habitat Conservation Initiative (NBHCI) Mini-Grants

Application deadline: Tuesday, March 15

These mini-grants of up to \$500 are intended to help Regional Conservation Partnerships (RCPs) support development of their own eBird trainings for their partners, and to help build an ambassador network to promote the tool's effectiveness in conservation and community engagement. #### Massachusetts Preservation Projects Fund (MPPF) Grant Program

#### Application deadline: Friday, March 18

This 50% matching grant reimbursement program supports the preservation of properties, landscapes, and sites listed in the State Register of Historic Places. Applicants must be a municipality or nonprofit organization. Potential applicants are strongly encouraged to view the MPPF <u>Application Presentation video</u>. Learn more and apply.

#### Stewardship Assistance and Restoration on APRs (SARA) Grants

#### Application deadline: Friday, April 1, 4:00 p.m.

The Stewardship Assistance and Restoration on APRs (SARA) helps resolve stewardship issues caused by a prior owner to restore active commercial farming on land that has already been protected through the Department's Agricultural Preservation Restriction (APR) Program. Funds may be used for materials and contracted labor or equipment rental costs to clear or reclaim

inactive fields that are out of production at no fault of the current owner. Learn more <u>here</u> and <u>here</u>.

#### Two USDA / NRCS Grant Opportunities

#### Application deadlines: Wednesday, April 13

The U.S. Department of Agriculture / Natural Resources Conservation Service (USDA / NRCS) will award up to \$225 million to conservation partners through the <u>Regional Conservation Partnership</u> <u>Program</u> (RCPP). The projects should address climate change, benefit historically underserved producers, and support urban agriculture.

#### **RCPP Classic**

Classic projects are implemented using NRCS contracts and easements with producers, landowners and communities, in collaboration with project partners. <u>Details here</u>.

#### **RCPP Alternative Funding Arrangements (AFA)**

AFA projects allow partners more flexibility in working directly with agricultural producers that would not be otherwise possible with Classic projects. <u>Details here</u>.

The Midwest Invasive Plant Network's <u>Invasive Plant Control Database</u> tool summarizes different management techniques for different invasive species. It gives ideal treatments with explanations of how they work, rates of application, and efficacy. This database was developed for the Midwest so it may not contain all Massachusetts' invasive species. **\*\*Note:** this database was developed out of state, and **may identify different pesticide rules and regulations than in Massachusetts. Review labels and protocols to ensure the herbicide and method of application is approved for MA.\*\***
