

# Collaboration Saves a Family Farm from Development in Seekonk

Source: Community Preservation Coalition (CPC) website Although the Medeiros family received offers from developers for their 40 acre farm that exceeded the \$2 million appraised value, they decided to have the town of Seekonk purchase it through the CPA program to preserve it for future generations. The historic chicken farm, known for its iconic red and white farmhouse and outbuildings, includes several open fields and swaths of forested wetlands. Through a collaboration between the local CPC, Seekonk town officials, and the Seekonk Land Conservation Trust, the town worked with the Medeiros family to develop a vision for the farm that will serve multiple needs for the community, while following CPA restrictions required for open space, outdoor recreation, and historic preservation. The proposal incorporated the preservation of historic farm buildings, and plans to

create new athletic fields, community gardens, and trails within the forested open space. In a resounding vote of 145 to 6, Seekonk Town Meeting approved this community-driven preservation project by appropriating \$2 million in CPA funds. Thanks to the foresight of the Medeiros family, this land will remain protected -- not only as part of the town's agricultural history, but also as a valuable outdoor resource for residents to enjoy for decades to come. Having passed the House last summer, An Act Preserving Open Space in the Commonwealth (S.524 & H.851), also referred to as the Public Lands Preservation Act, is now before the Senate Ways and Means Committee. MLTC's Executive Director Robb Johnson and fellow advocates had a encouraging meeting with Senate President Spilka earlier this month to urge Senate passage. ## New Marlborough and Other Communities Weigh Rules To Protect Dark Night Sky

The town of New Marlborough is poised to become one of the first communities in the Bay State to enact zoning legislation designed to prevent light pollution and make sure the night sky remains visible. An MLTC-supported bill (S.2147 / H.3306, An Act to Improve Outdoor Lighting, Conserve Energy, and Increase Dark-Sky Visibility) was recently reported favorably out of Joint Committee and is now before the Massachusetts Senate Ways and Means Committee. #### State Revolving Funds a Source for Conservation Funding

The Bipartisan Infrastructure Law, passed in November 2021, allocated \$11.7 billion to Clean Water State Revolving Funds (CWSRF). <u>Land acquisition and restoration</u> can be funded through the CWSRF, typically as a Nonpoint Source (NPS) project to protect water quality. Projects can take the form of conservation easements or fee simple purchases, or restoration activities such as tree planting. #### **Osprey on Power Poles**

Osprey often perch and nest on power poles and other utility equipment. This can be dangerous for the osprey and cause service reliability issues for customers. Given the abundance of osprey nesting on utility poles on Cape Cod, Eversource developed the Cape Cod Osprey Management Plan (CCOMP). Though the management plan is local, it could be extrapolated for your area. # Grants for Habitat Management Through the Massachusetts Collaborative for Private Forestland

Application deadline: Thursday, March 31

\$1.5 million is available to Massachusetts landowners who own forestland of at least 10 acres to help them plan and enable practices that benefit rare and declining habitats on private lands that can help vulnerable species; and expand on existing habitat projects on public lands. <u>Learn more</u>.

#### **Nellie Leamann Taft Foundation**

Deadline to request application access: Friday, April 1

Funding is focused on promoting greater human well-being by supporting grassroots and other efforts to promote clean air, protect water resources and coastal areas, and preserve open space resources, including recreational space and natural areas in urban, rural, and wilderness locations. Geographic focus is inside the Boston 495 beltway. Grants typically range from \$5,000 to \$15,000.

Preference is given to small to mid-sized organizations, and includes seed funding for new ideas and initiatives, start-up and on-going support for grass roots organizations, and entrepreneurial projects that may enable an organization or its constituents to achieve greater self-sufficiency. <u>Details here</u>.

#### **Climate Adaptation Fund**

Pre-proposals deadline: Friday, April 8

The Wildlife Conservation Society, through the Climate Adaptation Fund, offers grants to non-profits implementing ground breaking, science based projects using traditional and new conservation tools applied in strategic ways to help wildlife and ecosystems adapt to climate impacts. <u>Learn more</u>. <u>Applicant Guide</u>.

## Two USDA / NRCS Grant Opportunities

Application deadline: Wednesday, April 13

The U.S. Department of Agriculture / Natural Resources Conservation Service (USDA / NRCS) will award up to \$225 million to conservation partners through the <u>Regional Conservation Partnership Program</u> (RCPP). The projects should address climate change, benefit historically underserved producers, and support urban agriculture.

#### **RCPP Classic**

Classic projects are implemented using NRCS contracts and easements with producers, landowners and communities, in collaboration with project partners. <u>Details here</u>.

#### RCPP Alternative Funding Arrangements (AFA)

AFA projects allow partners more flexibility in working directly with agricultural producers that would not be otherwise possible with Classic projects. <u>Details here</u>.

#### Municipal Vulnerability Preparedness Program Action Grants

Application deadline: Thursday May 5

The Executive Office of Energy and Environmental Affairs (EEA) is seeking proposals for MVP Action Grants, which provide designated MVP Communities funding to implement priority climate adaptation actions identified through the MVP planning process or similar climate change vulnerability assessment and action planning that has led to MVP designation after EEA review. Projects are required to use climate data and projections. Projects that propose nature-based solutions or strategies that rely on green infrastructure or conservation and enhancement of natural systems and that have robust community engagement plans are preferred. Applicants can request up to \$3 million in funding (regional proposals may request up to \$5 million), and a 25% match of the total project cost is required (see RFR for new exceptions). #### Municipal Vulnerability Preparedness Program Planning Grants

Application deadline: Tuesday June 7

EEA is also seeking proposals for Municipal Vulnerability Preparedness (MVP) Planning Grants, which provide support for Massachusetts cities and towns to complete climate vulnerability assessments and develop action-oriented climate resiliency plans. The program helps communities define climate related hazards; understand how their community may be impacted by climate change; identify existing and future vulnerabilities and strengths; and develop, prioritize, and implement key actions. State-trained MVP providers offer technical assistance to communities in completing the assessment and resiliency plans. Communities that complete the MVP planning grant program become certified as an MVP community and are eligible for MVP Action Grant funding.
