# **Member Spotlight**



#### 245 Acres of Fieldstone Farm Conserved in Hubbardston

Fieldstone Farm is a history book that tells the story of Hubbardston's agrarian and logging heritage. The property, which sits on both sides of Lombard Road, adjacent to East Quabbin Land Trust's 94-acre Henry's Grove Preserve, is comprised of 245 acres of woodland, wetland and old fields. It bridges the east-west gap between the East Branch of the Ware River and Bickford Pond, connecting existing conservation lands and trails in Hubbardston and Princeton. The Mass. Department of Fish and Game identified the entire property as Critical Natural Landscape because of its vital location connecting woodland areas and unique habitats in the region. The land west of Lombard Road is especially important, including Priority Habitat of Rare Species and several vernal

pools. The streams and wetlands on the property, which form part of the greater Boston public water supply, are identified as an Outstanding Resource Water in Massachusetts. East Quabbin Land Trust now owns 150 acres of the former Fieldstone Farm and the CR is held by the DCR. The remaining acreage was sold to the DCR. Thank you to the many partners who made it possible to protect Fieldstone Farm from development!




#### Membership Season is Here!

#### **Untimely Loss of Two Massachusetts Land Trust Icons**

With appreciation for their lives and deep regret for their too-early passing, MLTC notes the loss of Peggy Stevens and Jim Lentowski. Each of them provided distinguished service to their home regions as well as the broader land trust community, providing guidance, counsel and friendship to many of us.

Jim Lentowski of Nantucket was a legend in life and will remain one long after his untimely death on July 6. As a friend to all, mentor, historian, teacher, visionary and the occasional



conscience, Jim regularly shared kind words of encouragement and offered patient and wise counsel. He was an unabashed believer in community – including our Massachusetts Land Conservation Community – regularly making the trek off "the Rock" to "America" to take part in Steering Committee meetings, the annual Land Trust/State Agency Retreat, and the MA Land Conservation Conference. He brought a smile to everyone's face, not only in recognition for his work, but also for how he built a community of friends, colleagues and landowners all joined together in the common goal of protecting land that needed to be protected. His passion for protecting Nantucket's open space was amazing. In over a half-century he left a conservation legacy that helped protect fully one half of the island. Jim was perhaps the best conservation storyteller on the

island. He was true to his Polish heritage wherever he went, sharing his background in the form of a Kielbasa sandwich, made from Blue Seal Kielbasa from Chicopee (the land of Jim's youth) with those lucky enough to be there.

His <u>obituary</u> appeared in the Nantucket *Inquirer and Mirror* on July 8. A funeral mass was held on his Rock on July 20. Memorial gifts to the Nantucket Conservation Foundation would be appreciated.



Peggy Stevens, a founding board member of MLTC while serving as Executive Director of the Westport Land Trust, succumbed to illness on June 24 in Virginia. Following an extensive career in health care, she embarked on a decade's work in land protection, creating landmark shifts in the work of the WLT and the Northern Virginia Land Trust. With her unique blend of passion, patience and softspoken persuasion, she made an outsized impact on the conservation community in two states, and a personal impact on many of us. She did much to move MLTC

forward in its formative years, especially in the governance realm. Relocating to Virginia, she led NVCT through a challenging transition by providing clear and focused leadership to create a dynamic, unified staff that laid the foundation for the organization's current successes. She then returned to the role of assisting land trusts statewide as Executive Director of Virginia's United Land Trusts.

Peggy had an active volunteer leadership life outside conservation. Her life-long passion was the Girl Scouts, where she held Board and Officer positions in three Councils and served most recently as Vice President of the World Foundation for Girl Guides and Girl Scouts. She also held volunteer non-profit leadership positions in several performing arts organizations, with women's leadership initiatives, and as Board Chair of Hostelling International USA.

Her obituary <u>is here</u>. A celebration of Peggy's life will be held in the spring of 2022 at a Girl Scout conference facility in eastern Massachusetts. # **Policy**

The \$5.3 billion in American Rescue Plan Act funding coming to Massachusetts presents a once-in-ageneration opportunity to invest in environmental infrastructure and the green economy, **but we need your help to make sure it happens!** The Joint Ways and Means Committee began a series of hearings on July 20 to gather input on how to allocate these funds. By the end of July, please reach out to <u>your state legislators</u> urging them to invest a significant share of those funds in the environmental programs you care most about! <u>See this letter</u> submitted by MLTC and key partners for our priorities and examples of language you could use.

#### **Charitable Conservation Easement Program Integrity Act reintroduced**

A bi-partisan group of federal legislators recently reintroduced the <u>Charitable Conservation</u> <u>Easement Program Integrity Act</u> (S. 2256 / H.R. 4164). This bill will put a stop to fraudulent tax deductions claimed by bad actors, costing the federal government billions in tax revenue -- \$9.2 billion in 2018 alone! As importantly, stopping this fraud will protect the integrity of legitimate deductions that help incentivize landowners to donate conservation restrictions. Please <u>call your members of Congress</u> today and urge them to cosponsor and support this bill. Your voice is critical to the process, and phone calls are an easy and effective way to be heard. #### **Conservation Land Tax Credit update**

Thank you to everyone who reached out to legislators to encourage passage of a budget amendment that would have expanded the Conservation Land Tax Credit. Unfortunately, the legislature did not adopt the amendment, so we'll continue to advocate for passage of a bill to raise the annual cap for this important program from \$2 million to \$5 million to address the significant backlog in eligible projects that many of you are working on. #### **New Model CR and Submission Form Available**

The state's new Model Conservation Restriction (CR), dated June 2021, is now posted on EEA's Division of Conservation Services' (DCS') Conservation Restriction Review Program webpage. The webpage has also been updated to reflect the current review process, and to answer many of the most common questions DCS receives. Some points to note: 1) The intake and review process is now entirely via email; 2) Using the commenting feature of MS Word is encouraged in initial drafts to explain changes/additions to the Model CR, and helpful in moving the review process along; and 3) If your organization plans to continue using your own unique Model CR, please update it according to the 2021 Model CR while retaining, as you believe necessary, the unique aspects of your templates. #### New Report on Mapping Lands to Save Plant Diversity as the Climate Changes

Native Plant Trust and The Nature Conservancy recently released Conserving Plant Diversity in New England, a comprehensive report that provides a scientific framework and detailed roadmap for conservation action and land protection at the species, habitat, and parcel scales to save plant diversity—and thus overall biodiversity—in New England as the climate changes. The report and its interactive mapping tool give policy makers, federal and state agencies, and land trusts the benchmarks and data to most effectively spend conservation dollars by protecting climate-resilient sites that capture plant and habitat diversity. #### CPA Statewide Revenue Projected to Top \$250 Million in Coming Year

Six months into 2021, the <u>total Community Preservation Act (CPA) Trust Fund revenue</u> is up by almost 100% compared to the same six months in 2020. Local CPA surcharge collections remain strong in each of the 187 CPA communities. - Environmental Science, Education and Outreach Grant Program provides funding for environmental science, education and outreach activities related directly to the Merrimack River or its watershed. Funds can be used for activities such as youth or public environmental educational activities, development of outreach and educational materials, river clean ups, water quality testing and monitoring activities, and other related activities.
