

Success Spotlight

Sudbury Valley Trustees: Wendler Property



Sudbury Valley Trustees (SVT) and the Town of Berlin have worked together to protect the Wendler Property, a 30-acre tract of forest in north Berlin. This property is entirely within a Natural Heritage & Endangered Species Program Priority Habitat for Rare Species and will provide a key connector between neighboring conservation properties, creating a 1,150 acre block of contiguous wildlife habitat. Neighboring conservation land includes 300+ acres owned by the Town of Berlin and SVT, including the Forty Caves Conservation Area, 157 acres of land in Bolton, including the Fyfeshire Conservation Area, and two Agricultural Preservation Restrictions. SVT pre-acquired the property before conveying it to the Town once funding was assembled. SVT holds a conservation restriction on the property, and is working to develop trails that will connect it to trail systems in Bolton and Berlin. Protection of the Wendler Property was made possible through funds from the Merrimack Conservation Partnership, the Fields Pond Foundation, and the William P. Wharton Trust. COVID-19 Corner

DOR Releases CPA Trust Fund Projections

The ongoing pandemic has made it extremely difficult to predict what communities will receive from the CPA Trust Fund in November. Revenue for the Trust Fund comes from filing fees collected at the state's Registries of Deeds (home sales, mortgage filings, etc.), but no one knows what the real estate market will look like between now and November. With that in mind, the Department of Revenue (DOR) has issued preliminary guidance on November's distribution to help municipalities finalize their

FY21 budgets. In order to be conservative, the agency's projection is based solely on revenue that was collected before April and is currently sitting in the Trust Fund. Almost all of this revenue came in prior to the Governor's state of emergency order in March. DOR says they will issue an update as it becomes clearer what registry collections are looking like in the coming months. Learn more [here](#).

New Law Allows Notary Publics to Witness Signatures via Video Conferencing

On Monday, April 27 Gov. Charlie Baker signed the remote notarization bill into law ([Chapter 71 of the Acts of 2020](#)), which provides a way to get documents notarized remotely. Notaries may perform their jobs through video conferencing until three days after the COVID-19 state of emergency is lifted in Massachusetts. The law only applies to parties in Massachusetts, and there are **restrictions to participation**. The notaries public can move forward and serve as witnesses for documents related to wills, caregiver authorization affidavits and other legal matters. For matters involving real estate, notarization has particular rules and must be managed through an attorney. Read details [here](#).

COVID Relief Coalition

The Massachusetts Attorney General's Office has joined a coalition of law firms, nonprofits, and government agencies-led by Ropes & Gray, Lawyers for Civil Rights, and Lawyers Clearinghouse-to launch the [COVID Relief Coalition](#) to provide vulnerable businesses and mission-driven organizations with pro bono legal support. The coalition offers quick, no-cost assistance and guidance from the local legal community to small businesses that complete an [intake form](#).

Incentives for Charitable Donations to Non-Profit Organizations

Two provisions in the CARES Act are designed to encourage tax deductible contributions to qualified nonprofits. The CARES Act allows taxpayers that do not itemize deductions to take a limited "above-the-line" deduction of up to \$300 on donations to a qualified charitable organization when computing adjusted gross income. For those who itemize, the CARES Act temporarily modifies the charitable contributions limitation. For individuals, the Act modifies the limitation from a maximum of 60% to 100% of adjusted gross income, while C corporations can deduct such contributions up to 25% of taxable income. Note that contributions made to donor advised funds are not eligible for these incentives. Your land trust may wish to consider opportunities to share these less-well known provisions of the CARES Act with current and prospective donors. However, as always you should take care not to provide tax advice, but rather encourage donors to seek input from a qualified professional.

State Issues Net Zero Determination

On April 22, the Mass. Executive Office of Energy and Environmental Affairs (EEA) released a formal [determination letter](#) establishing a net zero greenhouse gas (GHG) emissions limit for 2050. Net Zero emissions is defined as "A level of statewide greenhouse gas emissions that is equal in quantity to the amount of carbon dioxide or its equivalent that is removed from the atmosphere and stored annually by, or attributable to, the Commonwealth..." The letter sets an emissions goal of at least 85 percent below the 1990 level and notes that 85% emissions reductions and complementary negative emissions by or attributable to the Commonwealth "are technically feasible using existing technologies **including the protection and enhancement of natural sequestration resources in the Commonwealth and regionally.**" [emphasis added] Later this year, the Commonwealth will release a 2050 Roadmap outlining pathways to achieve the emissions limit and also the Clean Energy and Climate Plan which sets state goals and programs to achieve Net Zero.

SMART Emergency Regulations Comment Period

On April 15, the MA Department of Energy Resources released its updated and emergency regulations to the [Solar Massachusetts Renewable Target](#) (SMART). The Department is accepting comments on the proposed update through May 22. MLTC is encouraged by the state's inclusion of [land-use siting guidelines](#) that will prohibit solar energy development where at least 50 percent of the parcel's land area is designated

as Priority Habitat, Core Habitat, or Critical Natural Landscape. We would also like to see the "Greenfield Subtractor," which is the financial disincentive to build on forests and other open space, increased to five times its current level - as was originally proposed by DOER last year - and applied to the entire footprint of the project (not just the solar arrays), to further discourage development on such greenfields.

The Department is hosting one virtual public hearing to receive oral comments on the regulations. This hearing will occur on May 22 from 10 am - 12 pm. Written comments will be accepted on the SMART regulation and key guidelines until 5 pm on May 22, 2020. Great American Outdoors Act Organizational Sign-on Letter

Earlier this year the Land and Water Conservation Fund Permanent Funding Act was combined with national park maintenance funding into the Great American Outdoors Act (S. 3422). This bill has a high-level of bi-partisan support, including from the administration. Given the incredible amount of use of our public lands and trails have seen during the pandemic full funding of LWCF is needed now more than ever. New Bill Would Grant Broad Powers for Pesticide Spraying

MACC recently learned about an emergency bill proposed by Governor Baker about spraying for EEE: [H.4650, "An Act to Mitigate Arbovirus in the Commonwealth"](#). MACC opposes the bill, considering it a broad overreach. H. 4650 would exempt the State Reclamation and Mosquito Control Board from all state laws and allow them to conduct mosquito eradication measures anywhere in the Commonwealth, even if municipalities do not want spraying in their towns. The bill would allow the Mosquito Control Board to do this work based on a determination from DPH that there might be an elevated risk of mosquito borne disease in the next year. The bill has no sunset clause, and would overrule all other statutes (including the Pesticide Control Act, Massachusetts Endangered Species Act, water supply protection laws, Open Meeting Law, Public Records Act, etc.) as well as decisions by municipalities to not join a regional district because they don't want nuisance mosquito spraying. This bill would also overrule private property requests for exclusion from spraying. Inadvertent impacts from spraying are not considered, and there are no requirements for notification to communities or property owners prior to spraying. EPA Proposes Municipal Stormwater General Permit Modifications for Massachusetts

The U.S. Environmental Protection Agency (EPA) is proposing modifications to the 2016

Small Municipal Separate Storm Sewer System (MS4) general permit for Massachusetts communities. EPA's New England Regional Office issues Clean Water Act National Pollutant Discharge Elimination System (NPDES) permits in Massachusetts and New Hampshire. MS4 permits are NPDES permits that authorize certain discharges of municipal stormwater to surface waters. Stormwater is the largest contributor of pollutants to impaired rivers, lakes, streams, ponds, and other waters in Massachusetts, making MS4 permits key to reducing the harmful impact of polluted stormwater. The proposed modifications were developed through mediation between EPA and parties who challenged the underlying 2016 permit. EPA will accept public comment on the proposed modifications until June 8, 2020. State Awarded Funds for Restoration of Former Cranberry Bogs

The Baker-Polito administration has announced that the Commonwealth has received \$10 million in federal funds to support the ecological restoration of former cranberry

bogs. The Division of Ecological Restoration and 17 partner organizations will use the funds for 20 projects that will protect and restore 900 acres of historic wetlands on retiring cranberry farmland. The work will create habitat for fish and wildlife, help communities adapt to climate change, and permanently protect a total of 1,800 acres of open space. Study of Charles River Meadowlands Completed

A two-year study of the Charles River Meadowlands in Bellingham, Franklin, and Medway has been completed. The Charles River Natural Valley Storage Area is comprised of hundreds of acres of wetland acquired in the 1970s and 1980s for flood control, under management of the U.S. Army Corps of Engineers. The area has been gradually walled off from the public by roadways and rapid private development, but each of the towns has conservation land and other municipal holdings that abut the federal lands, effectively creating a large natural sanctuary similar in scale to the Great Meadows National Wildlife Refuge in Concord. Under the vision articulated by the Meadowlands Initiative, stewardship for flood control would remain the primary purpose of the area, but limited and strategically placed trails should allow the public to enjoy views and pursue recreational activities that do not conflict with conservation goals. This study was initiated by the Meadowlands Initiative and funded by a grant procured by three area legislators and the town of Franklin. Learn more [here](#).


Case Study: Climate Data Creates Connections

The Land Trust Alliance and the Open Space Institute have published a case study on the climate tools and mapping work done by the North Quabbin Regional Landscape Partnership (NQRLP). Since 2013, the NQRLP has focused on incorporating climate resilience into conservation planning and creating a digital map to identify climate resilient sites, becoming one of the first regional conservation partnerships to attempt a climate conservation plan on this scale. These climate tools created a shared language and understanding around climate change, allowing the NQRLP and other organizations to analyze conservation projects and identify priorities.

Sarah Wells, the coordinator of the NQRLP, offers the advice: "Don't be overwhelmed by the sheer volume of data. At the end of the day, you don't need 15 maps to tell every angle of the story. If you have one map that you feel good about, that your group can coalesce around and that can help you get some good work done, that's important. That's enough to get started."

Grants

Agricultural Conservation Easement Program -- Natural Resources Conservation Service

Deadline: May 15

This program provides financial and technical assistance to landowners interested in preserving agricultural land or wetlands through a conservation easement. Cropland, rangeland, pastureland, and nonindustrial private forests are eligible for agricultural easements. Farmed or converted wetlands that can be successfully and cost-effectively restored are eligible for wetland easements. Learn more [here](#).

Regional Conservation Partnership Program -- Natural Resources Conservation Service

Deadline: May 18

The Natural Resources Conservation Service is accepting applications for the Regional Conservation Partnership Program's (RCPP) Alternative Funding Arrangements. Eligible projects include those that use innovative approaches to leverage federal investment in conservation, deploy a pay-for-performance conservation approach, and seek large-scale infrastructure investment that generate conservation benefits. Grants will range from \$250,000 to \$10 million. Learn more and apply [here](#).

Watershed Grants -- EPA

The 2020 Southern New England Program (SNEP) Watershed Grants target integrated approaches to water quality and ecosystem restoration. SNEP recognizes that clean water, healthy habitats, resilient ecosystems, and prosperous communities are closely interconnected, and that strong partnerships offer the most effective means of meeting Southeast New England's environmental challenges. 2020 SNEP Watershed Grants will provide up to \$2 million in grants to encourage strategic investments by state, local, tribal, and regional partners. The source of the funding is federal, and grantees will provide additional non-federal matching funds totaling 25% of the overall project cost. Cash and in-kind contributions may be counted toward the match. The geographic region eligible extends from Westerly, R.I. to Pleasant Bay on Cape Cod, encompassing the major estuaries of Narragansett Bay and Buzzards Bay, and their watershed lands as far north as Worcester. In-Lieu Fee Program -- MA Department of Fish and Game

The Massachusetts Department of Fish and Game (DFG) anticipates the release of the 2020 Request for Proposals (RFP) for the [Massachusetts In-Lieu Fee Program](#) (ILFP) in June. This program funds aquatic resource restoration, enhancement, or preservation projects throughout the Commonwealth. Certain Army Corps of Engineers permittees pay a fee to DFG in lieu of providing on-site mitigation for project impacts. DFG uses these fees to award grants for larger-scale environmental restoration and land preservation projects. Eligible applicants include Massachusetts cities, towns, academic institutions, certified 501(c)(3) nonprofits, and other public entities. Up to \$3 million is available to coastal communities and eligible non-profit organizations to reduce risks associated with coastal storms and sea level rise impacts. Eligible coastal resilience initiatives include planning and public outreach, redesigning and retrofitting vulnerable municipally-owned facilities and infrastructure, and non-structural shoreline restoration approaches (such as beach, berm, and dune building; fringing salt marsh restoration; and coastal bank stabilization using bioengineering techniques).
